MPI compliance crackdown - Animal Status Declarations

Purpose

To urgently remind our members to ensure their drivers are carrying a completed NAIT (National Animal Identification and Tracing) declaration when transporting cattle or deer, in order to avoid a \$400 infringement fine per untagged animal. The Ministry for Primary (MPI) Industries have told Transporting New Zealand they will be taking a more proactive approach to enforcement over the coming months.

Background

The NAIT Act 2012 sets out legal requirements about the transport of cattle and deer. It is an offence under the NAIT Act to move cattle or deer unless the animal is fitted with the prescribed NAIT device (an ear tag), or an exemption applies.¹

Although it is farmers' (or other animal owners') responsibility to ensure their cattle and deer are tagged and registered before they leave their location (or apply for an exemption), transport operators can still be liable where a farmer has failed to do so. The infringement fine is \$400 per untagged animal. MPI and OSPRI are continuing to remind farmers that they are primarily responsible for tagging animals

¹ An exemption can be granted by OSPRI (the organisation managing NAIT) where animals are being moved directly to slaughter; to a game estate, safari park or zoo; or if they are fallow deer.

In order to avoid being fined, transport operators must ensure:

1. the person in charge of the animals has provided a declaration to the transport operator that the animal/s have been fitted with a compliant ear tag and properly registered with NAIT; **AND**
2. the transport operator carries or has access to the completed animal status declaration form at all times while moving the animal (either in hardcopy or electronic form).

Livestock operators may have observed MPI officers inspecting stock trucks unloading at saleyards over the last 12 months. MPI has been completing checks for any untagged NAIT animals and it will be continuing this proactive approach to ensuring compliance over the next few months.

What transport operators need to do

1. Take extra care to ensure that farmers or any other people in charge of animals provide them with a completed animal status declaration prior to transporting cattle or deer:
